



Checklist for a German national visa - student –

Before filling out the application form and booking an appointment, please prepare **2 identical sets** of the following documentation for your visa:

<input type="checkbox"/>	Valid passport (issued within the last 10 years and valid for at least another year as of date of visa application; passports with observations regarding the front data page cannot be accepted) with at least two empty pages
<input type="checkbox"/>	Application form & declaration (in accordance with Section 54 of the Residence Act) duly signed (2 copies)
<input type="checkbox"/>	Declaration for Additional contact and legal representation information (2 copies)
<input type="checkbox"/>	Copy of your passport's data page (A4 size copy) (2 copies)
<input type="checkbox"/>	Personal covering letter explaining the exact purpose and duration of stay (2 copies)
<input type="checkbox"/>	Proof of admittance to the study course/preparatory college (original and 2 copies) including information on the language of instruction
<input type="checkbox"/>	Where not confirmed by the University in the admission notification: Proof of the language skills in the language of instruction for the study course or the preparatory course (without a preparatory language course as a rule at least B2-level in the language of instructions) (original and 2 copies)
<input type="checkbox"/>	Where applicable: Certificates of other academic qualifications (original and 2 copies)
<input type="checkbox"/>	Curriculum vitae (2 copies)
<input type="checkbox"/>	Letter of motivation (2 copies)
<input type="checkbox"/>	Proof of financial means to cover the costs for the time of your studies by one of the following documents: <ul style="list-style-type: none">- confirmation of a German / EU scholarship / stipend or- "Verpflichtungserklärung" (formal obligation letter) by sponsor living in Germany or- blocked account for the first year of your stay, amounting to 10.356,-- € <p>When applying for visa, you can provide evidence that you are able to meet your living costs by opening a blocked bank account. You have free choice of provider. To the best of the Embassy/Consulate General's knowledge, the Kotak Mahindra Bank or Deutsche Bank or Capital India Finance Ltd offers blocked accounts in India that meet the requirements of the visa procedure. Information on providers that offer this service worldwide is available on the Federal Foreign Office website.</p> <p>PLEASE NOTE: You cannot withdraw more than 861,-- Euros per month from a blocked account. This is applicable from 01.08.2020. However, especially at the beginning of your stay, you might be required to spend more than 861,-- Euros in a month (e.g. to pay a deposit when renting a room or an apartment). It is therefore highly recommended to make sure that you have access to sufficient financial means according to your individual situation.</p>

<input type="checkbox"/>	Visa fee of 75 € payable in INR only (pls. check our website for payment options and applicable exchange rate)

<input type="checkbox"/>	Travel health insurance valid on arrival in Germany to the date of enrollment at the University (mentioned in your admission letter) (approx. 3 months). Kindly refer to www.india.diplo.de/visa to find out about the travel health insurances accepted
